



## **“Wonderland. Escape To A Season Of Enchantment” (Christmas Campaign)**

16 November – 25 December 2018

### **1. Tier 1: Redeem 2 Pieces of Jem Gift Wrappers**

- 1.1 Shoppers who spend a minimum of **S\$60** at any Stores, within a maximum of three (3) same-day receipts, from 16 November – 25 December 2018, are eligible to redeem two (2) pieces of **Jem Gift Wrappers**.
- 1.2 Gift redemption is limited to the first **200** shoppers only per day. Redemption is on a first-come first-served basis, while stocks last.
- 1.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 1.4 This redemption is **exclusive** from other gift-with-purchase promotions running between 16 November and 25 December 2018 (both dates inclusive). Receipts can only be used once for redemption of the Jem Gift Wrappers and cannot be used again to redeem any other gift-with-purchase promotions available between 16 November and 25 December 2018 (both dates inclusive).
- 1.5 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 1.6 **Purchase of Lendlease Gift Vouchers at the L3 Concierge Desk from 16 November – 25 December 2018 are strictly EXCLUDED from the redemption.**
- 1.7 The management will not replace any Jem Gift Wrappers in any case of loss, theft or damage.
- 1.8 All redemptions are available at Level 3 Concierge Desks. Last redemption is at 9.45pm.
- 1.9 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during redemption.
- 1.10 In meeting the minimum spend requirement, persons are NOT allowed to use vouchers and/or other in-store vouchers.
- 1.11 Gifts accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry.
- 1.12 All redemptions are further subject to the General Terms and Conditions as set out below.

### **2. Tier 2: Redeem an exclusive Wonderland Set**

- 2.1 Shoppers who spend a minimum of **S\$200 (S\$180 for Lendlease Plus members)** at any Stores, within a maximum of three (3) same-day receipts, from 16 November – 25 December 2018, are eligible to redeem an exclusive Wonderland Set [Includes one (1) Wonderland-inspired Umbrella + two (2) pieces of Jem Gift Wrappers].
- 2.2 Gift redemption is limited to the first **200** shoppers only per day. Redemption is on a first-come first-served basis, while stocks last.
- 2.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.



- 2.4 This redemption is **exclusive** from other gift-with-purchase promotions running between 16 November and 25 December 2018 (both dates inclusive). Receipts can only be used once for redemption of the Wonderland Set and cannot be used again to redeem any other gift-with-purchase promotions available between 16 November and 25 December 2018 (both dates inclusive).
- 2.5 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 2.6 **Purchase of Lendlease Gift Vouchers at the L3 Concierge Desk from 16 November – 25 December 2018 are strictly EXCLUDED from the redemption.**
- 2.7 The management will not replace any Umbrella & Jem Gift Wrappers in any case of loss, theft or damage.
- 2.8 All redemptions are available at Level 3 Concierge Desks. Last redemption is at 9.45pm.
- 2.9 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during redemption.
- 2.10 In meeting the minimum spend requirement, persons are NOT allowed to use vouchers and/or other in-store vouchers.
- 2.11 Gifts accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry. Shoppers are responsible for checking the umbrellas before leaving the counter, and strictly no exchange will be allowed upon leaving the Concierge Desks.
- 2.12 All redemptions are further subject to the General Terms and Conditions as set out below.

### 3. Earn 8,000 Bonus Points for New Sign Up as a Lendlease Plus Member

- 3.1 New sign up member can earn **8,000 Lendlease Plus Bonus Points** from 16 November – 16 December 2018. To sign up as a new Lendlease Plus member, shopper needs to download the app and sign up as a member with promo code “**WelcomeLLP**” for activation between 16 November and 16 December 2018 (both dates inclusive).
- 3.2 Reward redemption is limited to the first **9,000** new sign-ups only. Redemption is on a first-come first-served basis.
- 3.3 All new sign up must be submitted via the app during the Promotion Period from 16 November – 16 December 2018. Registration after the stated duration will not be entertained.
- 3.4 Each new member can get the bonus points instantly once successfully sign up within the first 9,000 new sign-ups.
- 3.5 All redemptions are further subject to the General Terms and Conditions as set out below.
- 3.6 Other Lendlease Plus Terms and Conditions apply.



#### 4. Wonderland Craft Station Activity Redemption

7 – 9, 14 – 16, 21 – 23 December 2018 (Friday - Sunday)

- 4.1 Shoppers who spend a minimum of **S\$30** at any Stores, within a maximum of three (3) same-day receipts, over the 3 weekends (Friday – Sunday) 7 - 9, 14 – 16, 21 – 23 December 2018 from 12pm – 9pm daily, are eligible for the Wonderland Craft Station activity.
- 4.2 All redemptions are available at Level 1 Jem Atrium. Last redemption is at **8.30pm**.
- 4.3 Redemption is limited to the first **150** shoppers only per day. Redemption is on a first-come first-served basis, while stocks last.
- 4.4 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 4.5 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 4.6 Shoppers must be physically present at the time of redemption and must show an original proof of purchase during redemption at Level 1 Jem Atrium.
- 4.7 In meeting the minimum spend requirement, persons are NOT allowed to use vouchers and/or other in-store vouchers.
- 4.8 Entry into the Activity Area is limited to **twenty (20)** kids per session on a first-come first-served basis, upon presentation of the receipts. The activities are recommended for children aged 3 and above. Each session is limited to 30 minutes and last entry is at 8.30pm.
- 4.9 Children should always be accompanied and supervised by their parents/guardians at all times. It shall be the sole responsibility of the parents/guardians to ensure the safety of their children and/or wards during activities.
- 4.10 Gifts accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry.

#### General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at 16 November 2018 to participate in any promotions or redemption events forming part of the **Wonderland. Escape To A Season Of Enchantment ('Christmas Campaign')**. Lendlease Retail Pte. Ltd. ("**The Management**") reserves the right to request for proof of age at any time.
- ii. All redemptions and participation in Promotion are available at L3 concierge desks (last redemption at 9.45pm), and must be made on the same day as purchase. Shopper's original personal photo identification (NRIC/ FIN/ Passport) and original proof of purchase must be presented during redemption.
- iii. All purchases made at retail, food and beverage and service outlets are eligible for the Promotion.



- iv. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, vouchers and/or other in-store vouchers, including the use of such prepaid cards, vouchers and/or other in-store vouchers as a form of top-up. Transactions made at money-changing facilities, top-up card machines or transactions in connection to the car park, purchases of cash cards/ gift vouchers/ memberships/ insurances/ travellers' cheques and payment of bills at any Jem outlet, **purchase of Lendlease Gift Vouchers** and SISTIC tickets from the Concierge Desk or atrium fairs (by non-Jem retailers) are strictly EXCLUDED.
- v. Notwithstanding the provisions herein, The Management reserves the absolute discretion to determine the eligibility of any person who is interested to participate in the Promotion. Such determination is final and conclusive, and The Management is not obliged to give any reason for disqualifying any person from participating in the Promotion.
- vi. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.
- vii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Jem or The Management, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Jem (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- viii. The Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- ix. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
- x. The Management reserves the right to vary these Terms and Conditions herein at any time at its absolute discretion without prior notice.
- xi. In the event of any inconsistency between these Terms and Conditions with any other form of publicity collaterals relating to the Promotion, these Terms and Conditions shall prevail.
- xii. This Promotion, and these Terms and Conditions are governed by the law of the Republic of Singapore and all participants are subjected to the exclusive jurisdiction of its courts in the determination of any matter or dispute arising in connection therewith.
- xiii. These Terms and Conditions listed are not intended to confer rights by a third party under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any provision of these Terms and Conditions.
