



“甜甜密密 庆团圆 Blissfulness. Relish Tradition In Your Own Sweet Time.” (Promotion)

11 January – 19 February 2019

1. Tier 1: Redeem a specially-designed red packet set (Eight (8) pieces per set)

11 January (Friday) – 4 February 2019 (Monday) (both dates inclusive)

- 1.1 Shoppers who spend a minimum of **S\$68** at any Stores, within a maximum of three (3) same-day receipts, from 11 January – 4 February 2019, are eligible to redeem a specially-designed red packet set (Eight (8) pieces per set).
- 1.2 Gift redemption is limited to the first **250** shoppers only per day. Redemption is on a first-come first-served basis, while stocks last.
- 1.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 1.4 This redemption is **exclusive** from other gift-with-purchase promotions running between 11 January – 4 February 2019 (both dates inclusive). General Terms and Conditions
