



**HAPPY-GO-LUCKY.
DRIVE AWAY THE BLUES WITH REWARDS SO PLENTIFUL. (“Promotion”)**

3 August – 31 October 2018

**1. JEMX MEMBERS EXCLUSIVE: MORE JOY WITH LESS POINTS
3 August – 31 October 2018**

- 1.1 JemX Rewards Members are entitled to use their accumulated Jem Points to redeem Jem Gift Voucher according to the table below:

Reward	Usual	Now
\$5 Jem Gift Voucher	800 Jem Points	600 Jem Points
\$10 Jem Gift Voucher	1,600 Jem Points	1,100 Jem Points
\$50 Jem Gift Voucher	8,000 Jem Points	5,000 Jem Points

- 1.2 Limited to five (5) redemptions per shopper per day, redemption is on a first-come first-served basis, while stocks last between 3 August and 31 October 2018 (both dates inclusive).
- 1.3 Jem Paper Voucher denomination will follow the redemption tier as stated in clause 1.1. Vouchers redeemed in the Promotion are only valid for six (6) months from date of redemption. No extension will be entertained.
- 1.4 Jem Paper Voucher denomination and expiry date will follow the eVoucher value upon conversion. Conversion of one (1) Jem eVoucher to Jem Paper Voucher is equivalent to one (1) redemption.
- 1.5 All redemptions are available at L3 Concierge Desk. Last redemption is at 9.45pm.
- 1.6 Purchase of Jem Gift Vouchers at the L3 Concierge Desk between 3 August and 31 October 2018 (both dates inclusive) are strictly EXCLUDED from the Promotion, and Jem Points will not be awarded.
- 1.7 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) during redemption.
- 1.8 All Jem Gift Vouchers redeemed cannot be transferred, refunded, exchanged for cash or kind and extended beyond its expiry.
- 1.9 The Management shall have final and absolute discretion regarding the distribution of Jem Vouchers based on stocks availability.
- 1.10 Other JemX Reward General Terms & Conditions apply and further subject to the General Terms and Conditions as set out below.



2. BIRTHDAY BONANZA 9 August – 12 August 2018

- 2.1 Shoppers who spend a minimum of **S\$53** at any Stores or L1 Jem Atrium Fair, within a maximum of three (3) same-day receipts, between 9 August and 12 August 2018 (both dates inclusive), are eligible to redeem one (1) EZ-Link Card worth \$10 **OR** two (2) EZ-Link Card worth \$5 each.
- 2.2 Gift redemption is limited to 180 shoppers per day. Redemption is on a first-come first-served basis, while stocks last.
- 2.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 2.4 This redemption is **exclusive** from other gift-with-purchase promotions running between 9 August and 12 August 2018 (both dates inclusive). Receipts can only be used once for redemption of the EZ-Link Card and cannot be used again to redeem any other gift-with-purchase promotions available between 9 August and 12 August 2018 (both dates inclusive).
- 2.5 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 2.6 All redemptions are available at L3 Concierge Desks. Last redemption is at 9.45pm.
- 2.7 Purchase of Jem Gift Vouchers at the L3 Concierge Desk between 9 August and 12 August 2018 (both dates inclusive) are strictly **EXCLUDED** from the Promotion, and Jem Points will not be awarded.
- 2.8 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during redemption.
- 2.9 In meeting the minimum spend requirement, persons are **NOT** allowed to use vouchers and/or other in-store vouchers.
- 2.10 Gifts accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry.
- 2.11 The Management shall have final and absolute discretion regarding the distribution of gifts based on stocks availability.
- 2.12 All redemptions are further subject to the General Terms and Conditions as set out below.



General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at 3 August 2018 to participate in any promotions or redemption events forming part of the Happy-Go-Lucky. Drive Away The Blues With Rewards So Plentiful Campaign (“**Promotion**”). Lendlease Retail Pte. Ltd. (“**The Management**”) reserves the right to request for proof of age at any time.
- ii. All redemptions and participation in Promotion are available at L3 concierge desks (last redemption at 9.45pm), and must be made on the same day as purchase. Shopper’s original personal photo identification (NRIC/ FIN/ Passport) and original proof of purchase must be presented during redemption.
- iii. All purchases made at retail, food and beverage, service outlets, and purchase of Jem Gift Vouchers are eligible for the Promotion.
- iv. No Guaranteed Gift With Purchase (Minimum spend required) for JemX+ Rewards members.
- v. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, vouchers and/or other in-store vouchers, including the use of such prepaid cards, vouchers and/or other in-store vouchers as a form of top-up. Transactions made at money-changing facilities, top-up card machines or transactions in connection to the car park, purchases of cash cards/ gift vouchers/ memberships/ insurances/ travellers’ cheques and payment of bills at any Jem outlet, purchase of Jem Gift Vouchers and purchase of SISTIC tickets from the Concierge Desk or atrium fairs (by non-Jem retailers) are strictly EXCLUDED.
- vi. Notwithstanding the provisions herein, The Management reserves the absolute discretion to determine the eligibility of any person who is interested to participate in the Promotion. Such determination is final and conclusive, and The Management is not obliged to give any reason for disqualifying any person from participating in the Promotion.
- vii. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.
- viii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Jem or The Management, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Jem (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- ix. The Management’s decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- x. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
- xi. The Management reserves the right to vary these Terms and Conditions herein at any time at its absolute discretion without prior notice.



- xii. In the event of any inconsistency between these Terms and Conditions with any other form of publicity collaterals relating to the Promotion, these Terms and Conditions shall prevail.
- xiii. This Promotion, and these Terms and Conditions are governed by the law of the Republic of Singapore and all participants are subjected to the exclusive jurisdiction of its courts in the determination of any matter or dispute arising in connection therewith.
- xiv. These Terms and Conditions listed are not intended to confer rights by a third party under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any provision of these Terms and Conditions.
