



TREASURES. FOR HUNTERS WHO KNOW WHERE TO SHOP. (GSS Campaign)

25 May – 24 June 2018

1. REDEEM A TREASURE MAP

25 May – 14 June 2018

- 1.1 Shoppers who spend a minimum of **S\$20** at any Stores, within a maximum of three (3) same-day receipts, from 25 May – 14 June 2018, are eligible to redeem a Treasure Map.
- 1.2 Redemption is on a first-come first-served basis, while stocks last.
- 1.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 1.4 This redemption is **exclusive** from other gift-with-purchase promotions running between 25 May and 14 June 2018 (both dates inclusive). Receipts can only be used once for redemption of the Treasure Map and cannot be used again to redeem any other gift-with-purchase promotions available between 25 May and 14 June 2018 (both dates inclusive).
- 1.5 Redemption must be made on the same day as purchase.
- 1.6 **Purchase of Jem Gift Vouchers at the L3 Concierge Desk from 25 May – 14 June 2018 are strictly EXCLUDED from the redemption.**
- 1.7 All redemptions are available at L3 Concierge Desks. Last redemption is at 9.45pm.
- 1.8 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during redemption.
- 1.9 In meeting the minimum spend requirement, persons are NOT allowed to use vouchers and/or other in-store vouchers.
- 1.10 Gifts accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry.
- 1.11 All redemptions are further subject to the General Terms and Conditions as set out below.



2. TREASURE MAP STAMP COLLECTION 25 May – 14 June 2018

- 2.1 Shoppers who present the original Treasure Map and a maximum of three (3) same-day receipts, from 25 May – 14 June 2018, are eligible to redeem:
- (a) **One (1) stamp at Checkpoint #1** when they spend a minimum of **S\$150 (S\$120 for JemX & JemX+ Rewards Members)** at Cathay, COURTS, FairPrice Xtra, H&M, Koufu, Marks & Spencer, Robinsons and/or UNIQLO, and will be eligible to redeem a **\$10 Jem Gift Voucher**. Limited to the first 2,000 redemptions on a first-come-first-served basis, while stocks last. Double spending required for FairPrice Xtra receipts.
 - (b) Or; **One (1) stamp at Checkpoint #2** when they spend a minimum of **S\$100 (S\$80 for JemX & JemX+ Rewards Members)** at any Level 1 / Level 2 retail stores excluding H&M, Marks & Spencer, Robinsons and UNIQLO, and will be eligible to redeem a **\$5 Jem Gift Voucher**. Limited to the first 500 redemptions on a first-come-first-served basis, while stocks last.
 - (c) Or; **One (1) stamp at Checkpoint #3** when they spend a minimum of **S\$100 (S\$80 for JemX & JemX+ Rewards Members)** at any Level 3 retail stores excluding H&M, Marks & Spencer, Robinsons and UNIQLO, and will be eligible to redeem a **\$5 Jem Gift Voucher**. Limited to the first 500 redemptions on a first-come-first-served basis, while stocks last.
 - (d) Or; **One (1) stamp at Checkpoint #4** when they spend a minimum of **S\$100 (S\$80 for JemX & JemX+ Rewards Members)** at any Level 4 / Level 5 / Level 6 retail stores excluding Cathay, COURTS, Koufu and Robinsons, and will be eligible to redeem a **\$5 Jem Gift Voucher**. Limited to the first 500 redemptions on a first-come-first-served basis, while stocks last.
 - (e) Or; **One (1) stamp at Checkpoint #5** when they spend a minimum of **S\$50** at any Basement 1 retail stores and F&B outlets excluding FairPrice Xtra, and will be eligible to redeem a **\$5 Jem Gift Voucher**. Limited to the first 500 redemptions on a first-come-first-served basis, while stocks last.
- 2.2 Redemption must be made on the same day as purchase. Limited to one (1) stamp redemption per shopper per day. Stamps are not required to be collected in order of numerical sequence. When vouchers for Checkpoint #1, Checkpoint #2, Checkpoint #3, Checkpoint #4 and/or Checkpoint #5 has been fully redeemed, stamp collection will still be available for the accumulation of stamps only to achieve a completed Treasure Map.
- 2.3 Shoppers who present an original completed Treasure Map with official Checkpoint stamps on Checkpoint #1, Checkpoint #2, Checkpoint #3, Checkpoint #4 and Checkpoint #5, at L3 Concierge Desk from 25 May – 14 June 2018, are eligible to redeem a **\$50 Jem Gift Voucher**.
- (a) Limited to one (1) \$50 Jem Gift Voucher redemption per shopper per day
 - (b) Limited to the first 1,500 redemptions on a first-come-first-serve basis, while stocks last
 - (c) Treasure Map shall be returned to Jem upon redemption of \$50 Jem Gift Voucher
- 2.4 This redemption is **exclusive** from other gift-with-purchase promotions running between 25 May and 14 June 2018 (both dates inclusive). Receipts can only be used once for redemption of each stamp and cannot be used again to redeem any other gift-with-purchase promotions available between 25 May and 14 June 2018 (both dates inclusive).
- 2.5 **Purchase of Jem Gift Vouchers at the L3 Concierge Desk from 25 May – 14 June 2018 are strictly EXCLUDED from the redemption.**
- 2.6 Only original Treasure Map are eligible for redemption and will not be accepted or replaced, if defaced, damaged and/or torn. Photocopies and photo images of Treasure Map will not be accepted.



- 2.7 Merging of multiple Treasure Maps and/or transferring of stamp(s) are strictly not allowed.
- 2.8 The management will not replace any Treasure Map in any case of loss, theft or damage.
- 2.9 All redemptions are available at L3 Concierge Desks. Last redemption is at 9.45pm.
- 2.10 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during redemption.
- 2.11 In meeting the minimum spend requirement, persons are NOT allowed to use vouchers and/or other in-store vouchers.
- 2.12 Shoppers are responsible for checking that one (1) stamp has been awarded on the respective Checkpoint of the Treasure Map before leaving the counter, and claims of stamps not awarded will not be entertained upon leaving the Concierge Desks.
- 2.13 All redemptions are further subject to the General Terms and Conditions as set out below.



3. 5X POINTS EVERY FRIDAY!

25 May, 1 June, 8 June, 15 June & 22 June 2018

- 3.1 **JemX Rewards Members** can earn a **maximum cap of 2,500 Jem Points** on 25 May, 1 June, 8 June, 15 June & 22 June as opposed to the usual daily maximum cap of 300 Jem points outside of the Promotion Period. To sign up as a new JemX Rewards member, shoppers need to spend a minimum of **S\$20**, in one (1) same-day receipt and present the receipt at our L3 Concierge desk for activation on the same day and within the Promotion Period.
- 3.2 **JemX+ Rewards Members** can earn a **maximum cap of 5,000 Jem Points** on 25 May, 1 June, 8 June, 15 June & 22 June as opposed outside of the Promotion Period:
 - (a) to the usual weekdays (Monday – Friday, regardless of Public Holiday), capped at a maximum of 600 Jem points.
 - (b) to the usual weekend (Saturday & Sunday), capped at a maximum of 300 Jem points.
- 3.3 Shopper who spent a minimum of **S\$20** in maximum one (1) same-day receipt will be eligible for the accumulation of Jem Points. In meeting the minimum spend requirement, shoppers are NOT allowed to use vouchers and/or other in-store vouchers.
- 3.4 A one-time membership activation process is required to be done in person at the L3 Concierge Desk for the application of JemX Rewards membership.
- 3.5 Existing JemX Rewards and JemX+ Rewards Members must submit their receipts via the app or kiosks within 24 hours of purchase or present it at the L3 Concierge Desk on the same day of purchase, between 10.00am and 9.45pm and during the Promotion Period. Submission of receipts after the stated duration will not be entertained.
- 3.6 Shoppers must be physically present at the time of submission of receipt(s) at the concierge desk and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during submission of receipt(s).
- 3.7 All redemptions are further subject to the General Terms and Conditions as set out below.
- 3.8 Other JemX Rewards Terms and Conditions apply.



4. RECEIVE A JEM 5TH ANNIVERSARY CAKE 15 June 2018

- 4.1 Shoppers who spend a minimum of **S\$50** at any Stores, within a maximum of three (3) same-day receipts on 15 June 2018, are eligible to redeem a Redemption Card to receive a 4-inch Flourless Chocolate Cake.
- 4.2 Redemption is limited to the first 500 shoppers on 15 June 2018 only. Redemption is on a first-come first-served basis, while stocks last.
- 4.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 4.4 Receipts can only be used once for redemption of the Redemption Card and cannot be used again to redeem any other gift-with-purchase promotions available on 15 June 2018.
- 4.5 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 4.6 **Purchase of Jem Gift Vouchers at the L3 Concierge Desk on 15 June 2018 are strictly EXCLUDED from the redemption.**

- 5.1 Shoppers who spend a minimum of **S\$120 (S\$100 for JemX & JemX+ Rewards Members)** at any Stores within a maximum of three (3) same-day receipts, from 16 June – 24 June 2018, are eligible to one (1) chance for a digital sure-win lucky spin to win Jem Gift Vouchers or Retailers' Gift Vouchers.
- 5.2 Redemption is limited to the first 150 shoppers daily from 16 June – 24 June 2018, on a first-come first-served basis.
- 5.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 5.4 This redemption is **exclusive** from other gift-with-purchase promotions running between 16 June and 24 June 2018 (both dates inclusive). Receipts can only be used once for redemption of the Treasure Map and cannot be used again to redeem any other gift-with-purchase promotions available between 16 June and 24 June 2018 (both dates inclusive).
- 5.5 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 5.6 **Purchase of Jem Gift Vouchers at the L3 Concierge Desk from 16 June – 24 June 2018 are strictly EXCLUDED from the redemption.**
- 5.7 All redemptions are available at L3 Concierge Desks. Last redemption is at 9.45pm.
- 5.8 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during redemption.
- 5.9 In meeting the minimum spend requirement, persons are NOT allowed to use vouchers and/or other in-store vouchers.
- 5.10 Prizes accorded from digital 'SPIN & WIN!' are not redeemable for cash, credit, or kind and extended beyond its expiry. Strictly no re-spin, refunds and/or exchanges.
- 5.11 All Jem Retailers' Gift Vouchers from digital sure-win lucky spin are subjected to individual retailers' terms and conditions.
- 5.12 Prizes of the digital sure-win lucky spin are subject to change at the absolute discretion of the Management.
- 5.13 All redemptions are further subject to the General Terms and Conditions as set out below.



GENERAL TERMS & CONDITIONS

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at 25 May 2018 to participate in any promotions or redemption events forming part of the **TREASURES. FOR HUNTERS WHO KNOW WHERE TO SHOP. ('GSS Campaign')**. Lendlease Retail Pte. Ltd. ("The Management") reserves the right to request for proof of age at any time.
- ii. All redemptions and participation in Promotion are available at L3 Concierge Desks (last redemption at 9.45pm), and must be made on the same day as purchase. Shopper's original personal photo identification (NRIC/ FIN/ Passport) and original proof of purchase must be presented during redemption.
- iii. All purchases made at retail, food and beverage and service outlets are eligible for the Promotion.
- iv. No Guaranteed Gift With Purchase (Minimum spend required) for JemX+ Rewards members.
- v. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, vouchers and/or other in-store vouchers, including the use of such prepaid cards, vouchers and/or other in-store vouchers as a form of top-up.
