



NINJAGO. THE ART OF PLAY TO MAKE A CHILD'S DAY ("March School Holidays Campaign")
5 March – 25 March 2018

1. Tier 1: Redeem a LEGO® NINJAGO® Activity Pass

- 1.1 Shoppers who spend a minimum of **S\$60** at any Stores or L1 Jem Atrium Fair, within a maximum of three (3) same-day receipts, between 5 March and 25 March 2018 (both dates inclusive), are eligible to redeem a LEGO NINJAGO Activity Pass.
- 1.2 LEGO NINJAGO Activity Pass entitles shoppers to receive entry to LEGO NINJAGO Spinjitzu Masters Challenge Event at L1 Jem Atrium, between 5 March and 25 March 2018 (both dates inclusive).
- 1.3 Activity Pass redemption is limited to the first 150 shoppers only per day. Redemption is on a first-come first-served basis, while stocks last.
- 1.4 The LEGO NINJAGO Activity Pass is valid **up to seven (7) days** from the date of redemption, and if the LEGO NINJAGO Activity Pass is redeemed less than seven (7) days before Sunday, 25 March 2018, such LEGO NINJAGO Activity Pass shall in any event expire on Sunday 25 March 2018.
- 1.5 Upon completion of the LEGO NINJAGO Spinjitzu Masters Challenge at L1 Jem Atrium, shoppers will receive a mystery LEGO gift to be collected at L1 Jem Atrium. Limited to the first 150 shoppers per day.
- 1.6 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 1.7 This redemption is **exclusive** from the \$5 Jem Gift Voucher redemption and other gift-with-purchase promotions running between 5 March and 25 March 2018 (both dates inclusive). Receipts can only be used once for redemption of the said LEGO NINJAGO Activity Pass and cannot be used again to redeem the \$5 Jem Gift Voucher and any other gift-with-purchase promotions available between 5 March and 25 March 2018 (both dates inclusive).
- 1.8 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 1.9 All redemptions are available at L3 Concierge Desk. Last redemption is at 9.45pm.
- 1.10 Shoppers must be physically present at the time of redemption and must show an original personal photo identification (including, but not limited to NRIC/ FIN/ Work Permit/ Student Pass/ Passport) and the original proof of purchase during redemption.
- 1.11 In meeting the minimum spend requirement, persons are **NOT** allowed to use vouchers and/or other in-store vouchers.
- 1.12 Entry into the Activity Area is limited to four (4) kids per session on a first-come first-served basis, upon presentation of the LEGO NINJAGO Activity Pass. The activities are recommended for children aged 6 to 14 years old. Each session is limited to 30 minutes, and last entry is at 8.30pm.
- 1.13 Children should always be accompanied and supervised by their parents/guardians at all times. It shall be the sole responsibility of the parents/guardians to ensure the safety of their children and/or wards during activities.
- 1.14 Gifts accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry.



1.15 All redemptions are further subject to the General Terms and Conditions as set out below.

2. Tier 2: Redemption of \$5 Jem Gift Voucher

- 2.1 Shoppers who spend a minimum of **S\$150 (\$120 for all JemX Rewards Members)** at any Stores, within a maximum of three (3) same-day receipts, from 5 – 25 March 2018, are eligible to a \$5 Jem Gift Voucher.
- 2.2 Gift redemption is limited to the first 150 shoppers only per day. Redemption is on a first-come first-served basis, while stocks last.
- 2.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 2.4 This redemption is **exclusive** from the LEGO NINJAGO Activity Pass redemption and other gift-with-purchase promotions running between 5 March and 25 March 2018 (both dates inclusive). Receipts can only be used once for redemption of the \$5 Jem Gift Voucher and cannot be used again to redeem the LEGO NINJAGO Activity Pass and any other gift-with-purchase promotions available between 5 March and 25 March 2018 (both dates inclusive).

General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at 5 March 2018 to participate in any promotions or redemption events forming part of the March School Holidays Campaign ("**Promotion**"). Lendlease Retail Pte. Ltd. ("**The Management**") reserves the right to request for proof of age at any time.
- ii. All redemptions and participation in Promotion are available at L3 concierge desks (last redemption at 9.45pm), and must be made on the same day as purchase. Shopper's original personal photo identification (NRIC/ FIN/ Passport) and original proof of purchase must be presented during redemption.
- iii. All purchases made at retail, food and beverage, service outlets, and purchase of Jem Gift Vouchers are eligible for the Promotion.



- iv. No Guaranteed Gift With Purchase (Minimum spend required) for JemX+ Rewards members.
- v. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, vouchers and/or other in-store vouchers, including the use of such prepaid cards, vouchers and/or other in-store vouchers as a form of top-up. Transactions made at money-changing facilities, top-up card machines or transactions in connection to the car park, purchases of cash cards/ gift vouchers/ memberships/ insurances/ travellers' cheques and payment of bills at any Jem outlet and purchase of SISTIC tickets from the Concierge Desk or atrium fairs (by non-Jem retailers) are strictly EXCLUDED.
- vi. Notwithstanding the provisions herein, The Management reserves the absolute discretion to determine the eligibility of any person who is interested to participate in the Promotion. Such determination is final and conclusive, and The Management is not obliged to give any reason for disqualifying any person from participating in the Promotion.
- vii. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.
- viii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Jem or The Management, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Jem (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- ix. The Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- x. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
- xi. The Management reserves the right to vary these Terms and Conditions herein at any time at its absolute discretion without prior notice.
- xii. In the event of any inconsistency between these Terms and Conditions with any other form of publicity collaterals relating to the Promotion, these Terms and Conditions shall prevail.
- xiii. This Promotion, and these Terms and Conditions are governed by the law of the Republic of Singapore and all participants are subjected to the exclusive jurisdiction of its courts in the determination of any matter or dispute arising in connection therewith.
