

So Much More At Jem! (“Promotion”)

Terms & Conditions

1. \$5 Lendlease E-Voucher Lendlease Plus Member Exclusive

3 March – 1 May 2023

- 1.1. Lendlease Plus Members are eligible to redeem Lendlease E-Voucher with a minimum nett spend of **S\$150** at Jem, within three (3) combined same-day receipts.

- 1.2. Receipts from FairPrice Xtra require double spending for redemption.
- 1.3. Lendlease Plus Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. E-Voucher(s) will be credited to their wallet in-app upon approval of qualifying receipt(s) within two (2) working days.
- 1.4. There will strictly be no conversion of redeemed E-Vouchers to physical Vouchers.
- 1.5. Redemption must be made on the same day as purchase and is limited to one (1) redemption per Lendlease Plus Member per day, regardless of total amount spent, on a first-come-first-served, while stocks last basis.
- 1.6. This redemption is exclusive from other gift-with-purchase promotions running from 3 March – 1 May 2023. Receipts can only be used once for redemption of the voucher and cannot be used again to redeem any other gift-with-purchase promotions available from 3 March – 1 May 2023.

2. Terrarium Workshop
