Terms & Conditions

1. Catch ‘N’ Shop

6 – 29 September 2024 (both dates inclusive)

- 1.1. Shoppers are eligible to redeem one (1) game chance with minimum nett spend of **S\$30** within one (1) same-day receipts at Jem from 6 – 29 September 2024 (both dates inclusive).
- 1.2. Receipts from FairPrice Xtra require double spending for redemption.
- 1.3. Redemption must be made on the same day as purchase and is limited to three (3) game chances per shopper per day, regardless of total amount spent.
- 1.4. To qualify for the game chances,
 - 1.4.1. Lendlease Plus Members must clock their spending by uploading receipts of minimum S\$30 nett spend via the Lendlease Plus mobile app. Game chances will be credited to their in-app wallet upon approval of qualifying receipts within two (2) working days; and
