1. Happy Monday Treats

1 Jul 2024 – 30 Jun 2025 (both dates inclusive)

- 1.1. Shoppers are eligible to redeem a S\$5 Lendlease voucher with a minimum nett spend of **S\$160** at Jem, within three (3) combined same-day receipts.
