Terms & Conditions

1. Happy Monday Treats

1 Jul 2024 – 30 Jun 2025 (both dates inclusive)

- 1.1. Shoppers are eligible to redeem a S\$5 Lendlease voucher with a minimum nett spend of **S\$160** at Jem, within three (3) combined same-day receipts.
- 1.2. Lendlease Plus Members are eligible to redeem a S\$5 Lendlease E-Voucher with a minimum nett spend of **S\$140** at Jem, within three (3) combined same-day receipts.
- 1.3. Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilisation, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- 1.4. The S\$5 Lendlease voucher shall be issued in the form of one (1) piece of S\$5 Lendlease voucher or Lendlease E-Voucher to qualifying members. The S\$5 Lendlease voucher or Lendlease E-Voucher is valid for use at Jem only.
- 1.5. Receipts from FairPrice Xtra require double spending for redemption.
- 1.6. The S\$5 Lendlease voucher and S\$5 Lendlease E-Voucher is limited to the first 500 redemptions every Mondays (except Public Holidays), on a first-come, first-served basis and while stocks last.
- 1.7. Lendlease Plus Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. The E-Voucher will be credited to their wallet in-app upon approval of qualifying receipt(s) within two (2) working days. There will strictly be no conversion of redeemed E-Voucher to physical Voucher.
- 1.8. Non-members can clock their spends by submitting same-day receipts at the L3 Concierge Desk.
- 1.9. Redemption must be made on the same day as purchase and is limited to one (1) redemption per shopper/member per day, regardless of total amount spent, on a first-come-first-served, while stocks last basis.
- 1.10. Vouchers issued cannot be exchanged for other denominations, cash and other gift prizes/ vouchers.
- 1.11. All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- 1.12. All redemptions are further subject to the General Terms and Conditions as set out below.

- iv. Only original receipts are accepted. Credit / debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts).
- v. Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilisation, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- vi. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.
- vii. There will strictly be no conversion of redeemed E-Voucher to physical Voucher.
- viii. For instalment payments, deposits and trade-in products, only nett amount paid on the same day of redemption is valid.
- ix. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption.
- x. In meeting the minimum spend requirement, persons are not allowed to use prepaid cards, as a form of top-up.
